

**DECISION OF RTA, MUVATTUPUZHA HELD ON 03-10-2013**

**Item No.1**

This is an application by Managing Director, KSRTC for fresh regular permit in respect of stage carriage **KL 15 4816** to operate on the route Piravom-Koothattukulam-Muvattupuzha-Kolenchery-Ernakulam Via Valiyapadam, Mannathoor, Pampakuda, Ramamangalam, Choondy, Puthencruz, Thiruvankulam and Tripunthura as ordinary service. Heard. Regular permit granted with proposed timings.

**Item No.2**

This is an application by Managing Director, KSRTC for fresh regular permit in respect of stage carriage **KL 15 6992** to operate on the route Muvattupuzha-Perumbavoor-Aluva as ordinary service. Heard. Regular permit granted with proposed timings.

**Item No.3**

This is an application for fresh regular permit in respect of Stage carriage [suitable vehicle not less than 2002 model ] with seating capacity not less than 33 in all to operate on the route Koothattukulam-Velloor Via Kakkoor, Anchelpetty, Mavinchuvadu, Mammalassery, Kakkad, Onakkoor, Piravom and Peruva as Ordinary service. Heard. The route is inter district in which 9 Kms falls under the jurisdiction of RTA Kottayam. Hence adjourned with a direction to the Secretary to seek concurrence from RTA, Kottayam.

**Item No.4**

This is an application for fresh regular permit in respect of Stage carriage **KL 05 L 5229** or suitable vehicle with seating capacity 28 in all to operate on the route Kothamangalam-Perumbavoor Via Kuruppampady, Odakkali and Thankalam as Ordinary service. Heard. The counsel of the petitioner offered stage carriage **KL 07 AG 8092**. The total route length is 19 kms and the route overlaps from Perumbavoor [Kalady Jn] upto the deviation at Kolenchery Jn for a distance of 700 mtrs in the Scheme Aluva-Kattappana which is within the permissible limit. Regular permit granted with a direction to settle the timings in accordance with letter No D3/875/STA/2005 of the STA.
