Guidelines for attending timing conference.

- 1.Only one person shall be permitted to attend for one vehicle.
- 2.One person can attend for more than one vehicle.
- 3.The Participant should be the Permit holder or the person duly authorized by the permit holder.
- 4.The participant should produce the attested copies of the RC and permit. Time sheet in original should be produced for attending the conference.
- 5.No person shall be permitted to attend the meeting without the original time sheet and authorization from the permit holder, if the permit holder is not attending the meeting.
6. The permit holder/applicant either in person or by authorized representative should attend the meeting . If the permit holder/applicant is absent the timings will be settled considering the objections of en route operators without further notice.
7. Without sufficient reasons ,proposed meetings will not be postponed.
